1 **JUDGMENT**

2 In accordance with, and for the reasons stated in the Amended Order Granting  
3 Final Approval of BrassCraft Settlement and Awarding Attorney Fees, Costs  
4 Reimbursement and Incentive Awards, judgment shall be entered whereby Plaintiffs  
5 Miles Houze, Susan Houze, Kevin Ngai, Marcia Price, and Henry Okonkwo (collectively  
6 “Plaintiffs”) shall take nothing from Defendant BrassCraft Manufacturing Company  
7 (“BrassCraft”) except as expressly set forth in the Settlement Agreement and addenda  
8 thereto, and the Amended Order Granting Final Approval of BrassCraft Settlement and  
9 Awarding Attorney Fees, Costs Reimbursement and Incentive Awards. Each side shall  
10 bear their own costs and fees except as otherwise ordered in the Amended Order Granting  
11 Final Approval of BrassCraft Settlement and Awarding Attorney Fees, Costs  
12 Reimbursement and Incentive Awards and in the Settlement Agreement.

13 No Class Members have made timely requests for exclusion from the Settlement.  
14 As such, this Judgment applies to all Class Members, except as provided in the  
15 Settlement Agreement and the Amended Order Granting Final Approval of BrassCraft  
16 Settlement and Awarding Attorney Fees, Costs Reimbursement and Incentive Awards.

17 Pursuant to California Code of Civil Procedure section 578 and 664.6 and  
18 California Rules of Court, rule 3.769(h), the Court, in the interests of justice and there  
19 being no just reason for delay, expressly directs the Clerk of the Court to enter this  
20 Judgment, and hereby decrees that upon entry, it be deemed as a final judgment with  
21 respect to all claims by members of the Class against Defendant BrassCraft and the  
22 Released Parties, in accordance with the terms of the Settlement Agreement.

23 Without affecting the finality of this Judgment, this Court reserves exclusive and  
24 continuing jurisdiction over the Settlement and the Settlement Agreement, including the  
25 administration and consummation of the Settlement Agreement.
